- 2. POSITIONS TO BE CONTESTED FOR ARE:
 - A. A FIVE-MEMBER BOARD
 - B. PRESIDENT
 - C. VICE PRESIDENT
 - D. SECRETARY
 - E. FINANCIAL SECRETARY
 - F. TREASURER
 - G. CHAPLAIN
- CANDIDATES SHALL DECLARE THEIR INTENTIONS ON OR BEFORE JULY 7, 2019 VIA TEXT OR EMAIL TO THE ELECTION COMMITTEE @ TEXT 763-291-1509 EMAIL enablematics enabled NOMINATIONS WILL ALSO BE MADE FROM THE FLOOR IF THE NEED ARISES.
- 4. MEMBERS OF THE BOARD AND EXECUTIVE OF THE ASSOCIATION SHALLL BE ELECTED AT THE ANNUAL CONVENTION BY SECRET BALLOT. NO BOARD/EXECUTIVE MEMBER WILL BE ELECTED IN ABSENTIA.
- 5. MEMBERS OF THE BOARD AND EXECUTIVE SHALL BE ELECTED FOR 2 YEARS.
- 6. THE OFFICERS SHALL BE INDUCTED INTO OFFICE ON THE SATURDAY OF THE WEEKEND OF THE ANNUAL CONVENTION.
